383	3.1 Environmental Performance Management Review	Discussion	EMS Performance Review bought to summarise environmental performance. This shows, despite reductions, we are slightly off track on Scope 1 and 2 emissions targets. This is partly due to grid carbon intensity increasing and new buildings coming online. There is potential funding (2% loan) with scope for this to be put towards increased solar provisions. Figures also show that the majority of Scope 3 emissions are from procurement, and it's noted that reductions in non-pay savings will help to reduce this		
384	3.1 Environmental Performance Management Review	Discussion	We will review Scope 3 emissions figures in the next session.		
385	3.1 Environmental Performance Management Review	Discussion	Taking this report or parts of it to Faculty leadership meetings may help increase the engagement and ownership as mentioned above. We could also increase the research input into these performance statistics for more coverage. There is pressure from People & Planet and the Students Union on promoting fewer roles in unsustainable industries. The 4 key areas are tobacco, mining, oil, gas and tar sands, and weapons trading. We currently have sign off for screening out fossil fuels and tobacco from jobs boards and career fairs, which allows for some People & Planet points on a partial commitment.		
390	3.3 Ethical Careers Policy	Discussion	This process is based on excluding businesses based on their practices rather than business views, and still allows for individual careers advice for students that seek it.		
391	3.3 Ethical Careers Policy	Discussion	Perceived issues faced currently include the Freedom of Speech Act and potential associated challenges. However, GD notes that legal advice has been sought on the freedom of speech act issue and there are no risks for us.		
392	3.3 Ethical Careers Policy	Discussion	We are accredited by the Association of Graduate Careers Advisory Services (AGCAS), and their values include impartiality, but Simeon notes that this commitment doesn't impact our impartiality. Additionally, the redesign and consequent centralised teams may be a challenge for faculty specificity.		
393	3.3 Ethical Careers Policy	Discussion	The current policy meets P&P partial commitment criteria due to tobacco and oil, gas and tar sands companies being screened out, and the new policy is a continuation of this (i.e. not banning mining and arms). The update is, however, looking at being university-wide, rather than just applicable to SEA. It was noted that Faculties can currently bring any companies to their own careers fairs.
